

How to Subscribe to a Really Simple Syndication (RSS) Feed

Background


The District of New Mexico Bankruptcy Court is offering a new option allowing external ECF users (regardless of party type) to subscribe to RSS feeds. The feed allows you to keep up with case information you are interested in by providing notification every time a docket entry is made within the last twelve hours. A link to the docket sheet and documents is available as part of the feed - except to documents that are private, restricted, or sealed. The information in the feed is searchable by case number, date, or title.

There are no PACER fees when viewing the feed. However, if you click on a case number hyperlink to view the docket sheet, or the document number hyperlink to view the document, you will be prompted to log in, and will incur the standard PACER fees for any information accessed through CM/ECF.

You may subscribe to the feed if you have configured third-party software. If you subscribe, the browser feed button will not be activated because the feed is not a traditional feed. The RSS feed works inside of CM-ECF (an inside server).

Procedure for Subscribing to the Feed

STEP	ACTION
1	Login to CM/ECF https://ecf.nmb.uscourts.gov
2	Click on the CM/ECF logo at the top left portion of the CM/ECF main page.
3	A Court Summary screen will appear. Click the Further court information link.
4	The top portion of the Court Information screen appears here. Click the Entries made in the last 12 hours - Public
