**NOTICE OF PROPOSED REVISED LOCAL RULES**

Pursuant to 28 U.S.C. § 2071, Fed.R.Civ.P. 83, Fed.R.Bankr.P. 9029, and Administrative Order No. 84-0324 of the United States District Court for the District of New Mexico authorizing the Bankruptcy Court to make local rules governing practice and procedure in bankruptcy cases and adversary proceedings in this district, the United States Bankruptcy Court for the District of New Mexico hereby provides notice that it proposes to revise the New Mexico Local Bankruptcy Rules.
